City Manager Olson stated that the Anna River application for final payment on the dock will be on the next agenda. The kayak launch was delivered to the Department of Public Works this afternoon. Regarding the old City Hall building the design and engineering is on schedule, they should be looking at the bids in January and construction should start as soon as possible. As for the SAW grant the kick off meeting will be next week, Commissioners are invited to attend. The logging project is half to three quarters completed in one parcel. They did do a clear cut in a small section on the west side for a new sand pit, final completion is to be in the next 2-4 weeks. Olson then informed the Commission that Consumers Mutual Insurance notified him on Tuesday afternoon that the small group coverage will no longer be offered. The state is handling a "wind down" plan that should be available by Friday. Our representative at Mazzali's Kim Moote will be keeping us informed. The City Employee Insurance Committee will also be meeting to come up with a recommended plan of action. Last Olson reminded everyone that the November 16th meeting was cancelled.
