6. City Manager Report

The past couple of weeks have been very interesting as we continue to cope with the realities of working within the confines of current COVID-19 environment. Our primary focus has turned to ensuring that our employees are exposed to as little risk as possible while still providing critical services. The staff of the City of Munising has proven to be adept in handling their changing work environment and I do not expect this to change. As for what the next month holds for the City, we are planning on maintaining

our status quo of staffing and service provision though the end of April. This trajectory is subject to change as State and Federal directives are issues regarding best practices.

The Alger County Emergency Management office is working under a declaration of emergency for the COVID-19 crisis. We are keeping track of salary and benefit costs as well as any potential hard cost that we will have in the weeks ahead and will submit for FEMA or state reimbursement after the fact. At this point we do not anticipate any extraordinary deviation from our budgeted expenditures with in the 2019-20 FY budget.

MDOT is continuing to move forward with the M-28 project as planned as transportation maintenance is considered critical infrastructure. The City of Munising portions are under budget as compared to our original engineering estimates and are being finalized as this point. An MDOT bid package error also accounted for a reduced cost of almost \$25,000.00 across the Water and Sewer portions. The USDA has reviewed our application for Sewer Funds and awarded grant funding for 75% of the project cost with a maximum amount for grant funds being \$1,852,000.00. The steps of moving forward with the USDA RD Grants/Loans have become increasing complex as their staff is now working remotely as well as our bond attorneys with Miller/Canfield. We do expect to have all grants and loans in place prior to the end of the current FY.

At this point we have instituted a schedule that seems to work well and minimizes exposure risks to our staff and the general public. As things progress through the month, I will be sure to ensure that any significant changes are communicated to all City of Munising employees and elected officials.
