- DDA Project—Milling has begun on the project streets in downtown Munising with paving beginning on Friday. Striping of parking, etc., will happen next Monday. Paving and painting may have rescheduling depending on weather conditions.

6. City Manager Report

The City is continuing to complete our fall season activities as we begin to look ahead to winter. The City Marina and Tourist Park are on the tail end of their seasons and a number of small facility improvements are slated to be completed prior to their seasonal closure. Paul's Plumbing and Kleiman Well Drilling are coordinating with Ron on when they can complete their respective installations. We anticipate a mid-October schedule with the final tie in of the new well system occurring roughly in late October or early November. A new pressure washer was purchased for the Marina this year and it is expected that the entirety of the fixed pier will be cleaned this fall. Both facilities saw steady use this year and did not have any major issues during the season.

The Contractor and subcontractor on the DDA street project has suffered a small weather-related delay this week. The milling sub-contractor had to push off their mobilization until Monday the  $19^{\rm th}$ . Milling should occur on the  $19^{\rm th}$  and  $20^{\rm th}$  with sewer structure adjustments and all remaining work and work prep occurring on the  $21^{\rm st}$ . The paving contractor is slated to spend the  $22^{\rm nd}$  and  $23^{\rm rd}$  paving the downtown with clean up and line painting being completed during the week of the  $26^{\rm th}$ . The City Commission and DDA Board have completed all of the required actions for the DDA capital improvement bond which is slated to be closed on or prior to the end of the month. The 45-day referendum period will expire on the  $22^{\rm nd}$  and Kathy Reynolds and myself will complete the documents needed to close on the bond.

MDOT and BACCO have officially completed all of the trunk-line reconstruction work on the MDOT project. A long list of small items continues

to be created and addressed. The water main that historically fed the west end of the City has been cut and capped near the intersection of W. Munising Ave. and Walnut St. The line has numerous known leaks and was over 120 years old in some sections. The ride quality surrounding some of the sanitary and storm sewer structures will be redone in the coming weeks as they are not up to ride quality specifications. PK painting has completed the majority of the accessory painting items on the project as well as the recessive line painting along the length of the project.

The City and our engineers, Coleman Engineering, are preparing documents associated with a new EGLE grant for our water system. The revised "lead and copper" rules force the city to take ownership of water services in the next few years and it is expected that over 800 services will need to be replaced in the next 20 years. We are preparing for the grant application process that would hopefully provide \$6.4 million to the City to perform these replacements. We anticipate having our intent to apply filed with the State of Michigan next month.

I will not be in attendance for the October  $17^{\rm th}$  City Commission meeting as I will be out west.

#### F. CORRESPONDENCE

Correspondence included a letter from Dan Malone regarding the Fire Department needs. The City will look at wage increases for the next fiscal year.
