My name is Joseph (Joe) Darter, and I am very interested in applying for the City Manager position with the City of Munising, MI. I have been employed in municipal government for over 13 years, with the City of Bloomington, Illinois.

My position as Property Manager with the City of Bloomington (population 80,000) is very similar to that of a small-City Manager. Central to my responsibilities as the Property Manager, my staff and I provide municipal services to our leaseholders, which includes all aspects of Public Works, Water, Parks and Recreation, Policing and Refuse services to our leaseholders surrounding our reservoirs. The Lake Bloomington community, situated within the townships of Hudson and Money Creek, in McLean County, both City of Bloomington and McLean County ordinances and regulations are enforced through my office. Because of this, I have been able to build strong relationships with all of the Departments of the City of Bloomington and the government of McLean County. I am very proud of my ability to work with different interests and groups to achieve the goals of all stakeholders.

In addition to the above stated responsibilities, I also manage the 70,000-acre watershed for our two drinking water reservoirs. Our watershed program is nationally recognized by the USEPA and the recipient of the National Water Quality Initiative. Through our partnership with the McLean County Soil & Water Conservation District, we have been awarded approximately \$1.5 million in grant funding through the IEPA, USDA and other agencies due to our success in combating nitrate and sediment loading into our two reservoirs. Through this partnership, we have built a strong relationship with farmers to educate and reduce nutrient loading, partnered with Illinois State University for a program that funds graduate students the opportunity to conduct water quality and hydrological studies that we then use within our watershed. Because of this, I have been reelected to the Board of Directors for the Illinois Lakes Management Association for a second term.

My desire to relocate to Michigan is not due to my career with the City of Bloomington. I absolutely love my career, the residents of Lake Bloomington and the staff members. However, the City of Bloomington is led by a very talented and dedicated Administration and therefore advancement is somewhat limited. I have a strong desire to push myself to new challenges and experiences and I feel that this will be best served by relocating to Michigan, a state where I have always wanted to live. I feel extremely confident that through my experience with the City of Bloomington and life experiences, I can effectively lead a City with dedication, honesty and passion.

While working full time for the City of Bloomington, I attended the University of Illinois at Springfield, earning a bachelor's and master's degree in Political Science in 2016.

- Oversees the City of Bloomington research contracts with Illinois State University and the University of Illinois for research conducted throughout our extensive watersheds. Works with Master level students on thesis projects that the City of Bloomington utilizes in grant applications.

- > Responsible for obtaining permits with Army Corps of Engineers for shoreline stabilization projects and wetland mitigation practices.
- Review permit applications to ensure that all City of Bloomington Codes and Water Department standards are met in consultation with the Water Director, residents and contractors.
- > Consults with various City of Bloomington and McLean County departments to coordinate and implement landuse decisions.
- > Yearly operating budget exceeds \$2 million annually.
- Manages seven (7) employees. Three staff members are union members and four are non-union full-time staff members.
