CITY MANAGER'S REPORT

Capital Projects

- <u>Tourist Park</u>- The West Bathroom rehabilitation project is moving along as our contractor is currently painting, sealing, and trimming the ceilings, walls, and doors. The next step will the installation of replacement fixtures and divider accessories. The project is still slated to be completed ahead of schedule with a "Grand Opening" in early June.
- Boat Launch- Gerou's continues to do site work and grade improvements at the launch. The intent is to get the launch area and lower parking lot established with compacted gravel subbase heading into Memorial Day week. One significant issue that has arisen is that the launch traffic has not respected the contractors barricades and closures which has resulted in many work stoppages as well as increased cost due to the destruction of survey and elevation markers. We will be working with the contractor on establishing effective traffic control to prevent any additional conflicts. As of now, the prime contractor has the paving lined up for the week of June 15th. Additionally, we were surprised to receive notice this week from the State of Michigan that we have been awarded grant funds for in-water and dock improvements that were removed from the current project. Upon completion of the grant agreement, the City will have three years to fund and complete the project which may require a Fall of 2026 construction start date.
- Street Improvements—
 washout damage in three areas this past week and have made
 recommendations for solutions. Cemetery Hill will be addressed by
 contractor when they perform the crush and shape job there this Summer.
 They had recommended that roughly 245 yards of gravel be added to the
 shoulders of H-58, and roughly 1150 yards of gravel be added to St.
 Martins Hill and Gage Rd. Following the washout, City staff installed
 two additional culverts in new locations on the street and have set
 them in advance of gravel placement. The City is currently soliciting
 gravel quotes as the road and shoulder repairs need to be addressed in
 order to prevent additional damage to the existing asphalt or ditches.
 BACCO was present at a preconstruction meeting and they have Cemetery
 Hill, Grand St., and the 300-500 blocks of Superior slated for a start
 date the week after the fourth of July.

Administrative Items

- Staff has been working on the budget and our capital improvement in anticipation of our upcoming budget introduction. We are also working on Identifying times in which we can hold budget sessions for the Commission to review municipal finance budgeting as well as reviewing the upcoming fiscal years proposed budget.
- Coleman Engineering representatives will be attending the June $4^{\rm th}$ meeting to review ongoing City Projects as well as provide a recommendation on a remedy for the Hickory St. landside issue.
- I will be out of the office the week of May $26^{\rm th}$ and will not be reachable. I will be returning to the office on June $2^{\rm nd}$.
