WHEREAS, the City of Munising desires to establish a Commercial Rehabilitation District for an area encompassing multiple properties in the proximity of 210 E. Superior St. located in the City of Munising hereinafter described; and

WHEREAS, the City Council of the City of Munising determined that the district meets the requirements set forth in MCL Section 207.655(1)(a) of Public Act 255 of 1978; and

City Manager's Report

The Fiscal Year for the City is coming to a close and we are working on wrapping the year in preparation for our upcoming audit. The DDA, as well as City Staff, will be working on preparing our Fiscal Year end budget adjustments as well as wrapping up all outstanding items prior to July 1st. The Alger Conservation District secured a tire collection grant for utilization within the County and the City partnered with Munising Township for a joint event. 401 tires were collected in 4 hours, of which, 90 were from residents within the City. We are hopeful that the City and Township can continue to work on events such as this in the future. There will be an E-waste collection event at the Munising High School on June 17th and 18th. The City applied for and was awarded the Community Energy Management Grant that we had applied for in April of this year. The grant will cover energy efficiency upgrades at a number of lift stations and well houses. The projects will include adding pink board insulation to all of the brick walls, replacing exterior doors, upgrading pump controls to VFD's, and changing out our heat source from electric to natural gas. EGLE would cover \$24,650 of the projected \$48,650 in hard costs of the projects. Depending on the lead time of materials, the City would like to have the majority of the envelope improvements completed by this upcoming heating season. Public Works staff along with Marina staff have been working on putting our floating dock into service for the year. Due to the substandard bottomlands in our marina, all of our steel piers have sunk into the soil/sawdust which causes a separation from the floating docks. The City of Marquette graciously gifted us a number of their longer unused steel pipes that their docks no longer need and we are preparing to put them into service. We are also putting an order into our steel supplier for other components that can be fabricated in house. Last year the Commission approved a \$20,000 dollar expenditure for Floatation Docking Service to provide the material and services however they have not been able to fit us into their schedule. They recommended that we source the materials and install the items while remaining available for feedback throughout the process. When complete, the last item will be addressing the revetment wall connection and modifying it to resemble the solution that the City of Marquette has put in place. The past couple of weeks I have received numerous questions regarding the status or our street sweeper and its lack of use this spring. The unit is not operational and is awaiting new brushes as well as some driveline repairs. This will hopefully be rectified in the 10 days and the sweeper will be out cleaning the streets all summer.
