CITY MANAGER'S REPORT

### Capital Projects

- Varnum Street- Gerou Excavating has finished the utility replacement portion of the project. This past week the contractor has prepped the construction zone for curb and gutter installation. The project is still on schedule with substantial completion occurring in September. The roadway on the eastern most block of the project will be expanded to accommodate two way on-street parking while still allowing safe passage of vehicles. This part of the project has received numerous positive reviews from Alger County employees as the parking was extremely tight in the winter months.
- Cemetery Fence— The fence at the Cemetery was completed late last month by Marquette Fence. A new portion of fencing in the Southwest corner of the cemetery was installed to help delineate the County road right of way and the cemetery property. This will help keep unauthorized users such as ORV's and snowmobiles out of the cemetery as they have caused damage in the past trying to cut the corner.
- <u>M-28 -</u> I met with the Newberry MDOT TSC staff this past week to discuss the remaining items that need to be addressed along the M-28 corridor through town. As of now the State and their contractor, BACCO, are finalizing the paperwork to complete the installation of a crosswalk at Birch Street, finish the line painting on the multiuse path, and rehabilitate the flashing school zone signs and controls. They are continuing to work on negotiating a price and scope items for the replacement of dead trees as well as other restoration items.

#### Administrative Items

- The Superior Watershed Partnership, UPPCO, and the City are preparing for the final installation of the fast-charging EV stations in the City Hall parking lot. UPPCO completed the power drop and panel installation last month and the charger company will be onsite this upcoming month to complete the installation of the charger infrastructure.
- Staff members from the Alger Conservation District, Trust for Public Lands, and myself will be traveling to Traverse City on August 14th for the Michigan DNR Trust Fund Board meeting. We have been invited by the board to give a presentation on our Munising Bay Overlook Acquisition application that was submitted in March. As of now, the United States Forest Service has provided a notice of award for our Community Forest program application for the federal funds on the project as our application will be the highest scoring application that is funded this round.
