The City of Munising and Coleman Engineering are moving forward on the application for USDA-RD's funds for street, water, and sewer improvements along Washington St.

Per the USDA-RD project requirements, the City must front the costs associated with the preliminary engineering and application functions prior to the final approval and closing on any grant or loan dollars. Once the USDA-RD funds are secured then the City can utilize the USDA-RD funds to reimburse the appropriate source of funding. Below is the cost breakdown of expenses that the City will need to incur prior to closing on our federal dollars.

The funds as presented will be moved from their source funds and into our internal capital improvement fund. This will allow staff to easily track project expenses during the preliminary stage. No inter-fund loan agreement is required for this project as the source funds are being utilized for their intended use.
