# IX. City Manager Report:

Devin Olson stated that UPPCO is upgrading all of the overhead streetlights to LED. Devin stated that the City is preparing for the 2019 roadwork for Sand Point Rd. Devin also stated that our big project for next year is our Flat Phase 2, to fix H58.

Devin Stated that there are 2 bills right now that would affect local government, which is the House Bill 4503, which would take away the ability of any local government to have any zoning regarding any short term rentals.

Devin stated that the other one being a bill that was just introduced back in 2012-2014 the state of Michigan gave a 100% disabled veterans property tax exceptions, they passed a bill that stripped the local government of revenue. There is a bill inside the senate right now, to force the state to make up the difference that the local governments are missing out on.

Devin stated that MDOT is still working on their preliminary plan, from the Krist Oil, to the Shell station.

John Hermann asked about a bike path on Washington St., Devin stated that we can paint all we want, on Washington St. Mike Nettleton suggested talking to the residents on Washington St. To see which side of the street to paint the line for the bike path.
