#### MUNISING CITY COMMISSION REPORT MUNISING DDA & PARTNERSHIP May 21, 2018

On Monday, May 21 I will be attending an Upper Peninsula Economic Development Alliance board meeting (I serve as Vice-Chair), their regional spring conference/meeting and the Business Leaders of Michigan meeting in Escanaba. Also, as part of the late afternoon meeting, I will be taking part in another regional meeting regarding wages and workforce in the Upper Peninsula. Art in the Alley is progressing, and Superior Watershed will be working with our office from Wed., May 23-25 on cleaning up the green space in that alley, etc. Our hope is to have the alley near completion by the end of June with continual updates throughout the summer and beyond.

The Chamber dinner was a success with Bowerman Funeral Home receiving Employer of the Year and over 100 attendees.

Currently leading the Alger Co. Munising Art Place grant award allotment for our county. The award for six counties in the central region was \$460,000 (minus CUPPAD's administrative fee) with each county being represented. I will be making sure Alger Co. Munising receives their allotted amount and

these projects will be determined in the coming months. The funds need to be expended by the end of 2019.

Performed site visits with the MI Department of Agriculture and Rural Development at Timberproducts, Trenary Toast and VanLandschoots. These discussions relate to workforce, business challenges and other issues/funding opportunities, etc. These types of meetings happen with their office and other state/governmental offices and businesses typically on a bi-monthly basis.

Pictured Rocks Days along with Yoopers Ride free cruises is coming up Saturday and Sunday, June 9 & 10. Our office is busy with that event. One of the 250 site selectors in the country (over 53,000 communities that they cover) was here in the Upper Peninsula. He spent his first of three days in Munising where I met with him to discuss livability and tourism in the Upper Peninsula. I also took him along with the Delta Co. economic developer to waterfalls and Miners Castle (beautiful day to make this tour). In Alger Co. we also spent time at the MSU extension in Chatham. At the end of his 3-day visit he conducted a swat analysis. With this report Munising was mentioned as the "Vail of the U.P." and was very impressed with our area here in Munising along with our future growth possibilities.

On Friday May 4, I was invited and attended Gov. Snyder's discussion and workshop regarding the Marshall Plan for Michigan which deals with skilled trades, training and education initiatives and funding.

# 15. City Manager Report

City Manager Olson began by stating that BACCO will be closing H-58 to thrutraffic Tuesday, May 29th. It will remain open for local traffic (Mill, ALTRAN, Forest Service, ACAS). The City will be rebidding the MDARD Mill overlay, included storm sewer and put the bid at 30% over budget. Removing storm sewer items and rebidding the pavement portion, bids due late next week. UPPCO street light upgrade, they have upgraded 5 street lights in town to LED, they will begin a service area wide replacement of HPS in 2019. There should be a significant reduction in consumption charges for the City. Olson then informed the Commission that Monday, June 4th, will be the Marina Ribbon Cutting at 11:00 a.m. Over 24 boats on the floating dock this weekend with only positive reviews, almost 40 boats were in the marina this weekend. Master and Gerou still have punch items to take care of. Last Olson stated that the City has fixed a leaking main at the Bullivant-H-58 intersection this week. This is the 4yh water issue at that intersection in 5 years.
