

CITY OF MUNISING  
STREETS AND SIDEWALKS

ORDINANCE NO. 15

An ordinance to regulate the alteration of streets and sidewalks in the City of Munising.

THE CITY OF MUNISING ORDAINS:

SECTION 1. No street, alley, sidewalk, public property, or public right-of-way shall be cut, trenched, excavated, or altered or improved, and with respect to sidewalks, repaired or installed, by any person without first having a written permit from the City.

SECTION 2. Application for such a permit shall be on forms furnished by the City.

SECTION 3. The fee for said permit, payable in advance, is thirty (\$30.00) dollars. Said fee shall be doubled if work is commenced prior to obtaining the permit. Paying a double fee does not waive other penalties provided for herein.

SECTION 4. Applicant for a permit and/or his agent and/or contractor doing the work shall, before the issuance of the permit:

(A) Furnish bond or insurance to hold the City harmless and/or free of liability arising out of said work.

(B) Prove he is not delinquent in payment due the City on prior similar work.

(C) Prove he is competent and equipped to do the proposed work.

(D) Show he has proper licenses to do the work.

(E) Submit a written plan and sketch of the work to be done.

SECTION 5. All work shall be subject to inspection by the City. The City Clerk shall be notified by the permittee before starting work, before starting any back-filling, and upon completion of the work. Permittee shall not proceed with any further work in each instance until being authorized by the City Clerk and/or the City Manager.

SECTION 6. Applicant shall adequately barricade his work and shall install sufficient warning lights and signals to protect the public.

SECTION 7. A permit shall expire for work not started within thirty (30) days or completed within sixty (60) days after the issuance of a permit, and a new permit shall be required before beginning or completing the work.

SECTION 8. Any person convicted of a violation of this ordinance shall be punished by imprisonment for not more than 90 days, or a fine of not more than \$500.00, or both.


SECTION 9. All ordinances or parts of ordinances conflicting with the provisions of this ordinance are hereby repealed; provided, however, that such repeal shall not have the effect of releasing or relinquishing any offense or penalty incurred prior to this date.


SECTION 10. If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portions shall be deemed a separate, distinct, and independent provision, and such holdings shall not affect the validity of the remaining portion.

SECTION 11. The City Clerk shall publish this ordinance in the manner required by law.

SECTION 12. This ordinance shall be in effect in this governmental until ten (10) days after its date of publication.
